LIMITED WARRANTY

Main Door Corp. warrants that its product line of doors, sidelites, transoms and components shall be free from defects in materials and workmanship for a period of one year from the date of shipment to The Home Depot, provided that the Main Door Corp. product was properly installed, protected and maintained.

❖ WHAT MAIN DOOR CORPORATION WILL DO:

Should a Main Door Corporation product fail to conform to its full written warranty*, Main Door Corporation will, at its option, either:

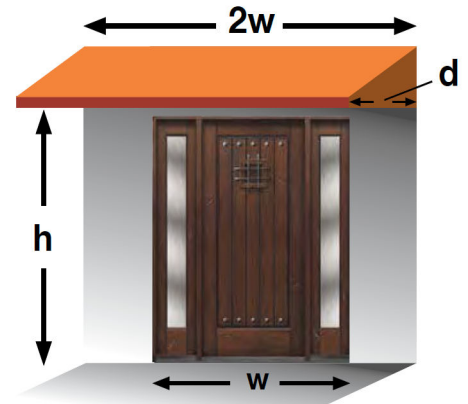
1. Repair the product found to be factory defective, or:
2. Provide a replacement part or parts to repair the product found to be factory defective, or:
3. Provide a replacement product in the same factory condition of fitting and finishing as the product that has been ordered originally, or:
4. Refund the homeowner will be processed by The Home Depot upon approval of Main Door Corporation.

IN NO EVENT SHALL MAIN DOOR CORPORATION PAY FOR TRANSPORTATION, SHIPPING, LABOR OR INSTALLATION CHARGES OR COSTS INCURRED IN REPLACING DOORS, SIDELITES, TRANSOMS AND COMPONENTS OR FINISHING OF ANY ORIGINAL REPLACEMENT PRODUCT, ALL OF WHICH SHALL BE THE SOLE RESPONSIBILITY OF THE END-USER MAKING THE WARRANTY CLAIM.

❖ IMPORTANT CONSIDERATIONS:

- All solid wood pre-hung and pre-finished exterior entry doors require adequate protection from the elements. Lack of proper overhang will void the warranty! The projected overhang depth must be equal or greater than $\frac{1}{2}$ the overhang height for North and East facing doors and equal to the overhang height for South and West facing doors. Overhang width must be twice the width of the door (see graphic).
- Unfinished units must be sealed within 7 days of receipt.
- Storm door installation voids warranty.
- Recommended cleaning use a damp cloth, no oils, no solvents, no chemicals or direct water.

❖ WARRANTY CLAIM PROCESS:

Upon discovering that the door is defective or fails to conform to this one year limited warranty, the homeowner MUST go to The Home Depot store within 24 to 48 on hours of the date the defect was discovered, and file a Service Request Warranty Claim.

Once Main Door Corporation (or its representative) gets the written claim proof of purchase order number with the homeowner name, phone and address, it will exercise its option to inspect, repair, provide a replacement or refund the homeowner.
